### Introduction

To protect the personal data of individuals and customers in the European Union and to keep up with new technology, as per the May 25, 2018 the General Data Protection Regulation (GDPR) will come into effect. The GDPR impacts every organization, club, society which stores or processes personal data of individuals across the European Union.

We at Photo Society Janez Puhar - Kranj (FDJP) are of course following the guidelines of GDPR protecting your personal data in any way possible. We have always done that. GDPR doesn't make a difference

### Who we are?

Photo Society Janez Puhar – Kranj is a society dedicated to bringing people together that are passionate about photography; be it taking, developing, looking at or discussing photos. Whether you are just beginning in photography or have been shooting for several years we have something for you. We meet weekly and run regular photo discussions and workshops.

We are strongly engaged in salon “*miniature*” organization, organized in compliance with the rules and regulations set by the International Federation of Photographic Art (FIAP) and the Photographic Association of Slovenia (FZS), is open to participants from countries all over the world. And further more national salon “*Pokrajina*” under FZS patronage.

### What information do we collect?

Types of the personal information that we collect: first name, last name, address, postal code, city, country, email, FZS and-or FIAP distinctions.

- All stated personal data are collected via online form, running on the official site of the miniature salon: <http://miniature.fotodrustvo-kranj.si>
- The same data are also collected in paper form. After you have successfully submitted the photographs and your personal data in digital form, you will receive the completed application form to your e-mail address. Must be printed out, signed to confirm that you agree to FIAP terms and conditions and our GDPR privacy policy. Paper form should be enclosed with the paper photographs you are sending via snail mail.

### How do we use personal information?

We may use your personal information for:

- salon result processing and preparation,
- salon results publishment on the official miniature site,



- salon results publishment in printed catalogue
- each author will receive a copy of the catalogue to the mailing address provided,
- each author will be informed about our salons updates and other major events organized by Photo Society Janez Puhar – Kranj

### **What legal basis do we have for processing your personal data?**

Consent – the individual (a data subject) whom the personal data is about has consented to the processing. Consent is freely given.

### **When do we disclose your personal data?**

We will treat personal data confidentially. We will disclose your personal data:

- name,
- surname,
- country,
- photographic distinctions (FIAP and FZS)

for salon result publishment only on official miniature page and for printing in paper catalog.

### **How long do we keep your personal data for?**

Until you unsubscribe from mailing list (available in every mail we send to you) or you can request to delete all your personal data using:
